Narrative

On Saturday, July 16th, 2010, I was on uniformed duty in an unmarked police cruiser assigned to the Admisinstration Section, working 7:00AM-3:30PM. At approximately 12:44PM, I was operating my cruiser on Harvard St. near Easy St.. At that time, I overheard an ECC broadcast for a possible break in progress at 123 Easy St.. Due to my proximity, I responded. When I arrived at 123 Easy St. I radioed ECC and asked that they have the caller meet me at the front door to this residence. I was told that the caller was already outside. As I was getting this information, I climbed the porch stairs to the front door. As I reached the door, a female voice called out to me. I turned and looked in the direction of the voice and ... Observed the white female, later identified as Rachel Borke. Borke, who was standing on the sidewalk in front of the residence. I witnessed a telephone in her hand and told me that it was her who called. She went on to tell me that she observed what appeared to be two white males with backpacks on the porch of 123 Easy St.. She told me that her suspicions were aroused when she observed one of them wedging his shoulder into the door as if he was trying to forgo entry. Since I was the only police officer on the location and had my back to the door as I spoke with her, I suggested she wait for other responding officers while I investigated further.

NARRATIVE

The writer of this report was contacted by an anonymous subject whom indicated that she thought there were possibly two white males trying to break into a house next to 123 Easy St. She described the house as being white with grey trim. She described the subjects as wearing all balck with a white t-shirt underneath his hoody and wearing red and black sneakers. While on the phone with the caller she was telling me she could see the subjects had went around the back of the house, she could see the subjects loitering around the back of the house and then they disappeared, this led him to believe they had made an entry into the house. The writer of this reportkept the caller on the line until he could see the officers approaching on foot. While I was on the phone with the caller, I could hear one of the officers holler at the subjects to "get down." I then ended the call.
